II. APPROVAL OF MINUTES

Member McIntyre made a motion to approve the meeting minutes from August 20, 2025. Member Pickelmann supported. Motion passed (7-0).

III. DIRECTORS REPORT, RACHEL HORTON, DIRECTOR, ANIMAL CONTROL

- 1. Events Upcoming Heritage Homecoming parade and Carrollton Homecoming parade. Bissell Empty the Shelters. Dogs Playing for Life Training, this is a nationally recognized program, and trainers will be onsite for 4 days training on playgroups and clarity around euthanasia
- 2. Volunteers September 24th meeting at 5PM to go over better impact, reach out to Alex if you need help one on one.
- 3. Court Cases Received custody of 6 dogs through court proceedings. These dogs were transferred out of County deliberately to protect them.
- 4. MDARD The transfer of dogs to rescue partners has cleared some space to paint in the dog run hallway which is the last item on the MDARD report that needs attention.
- 5. ACO's Interim ACO's Emilio and Katie are almost complete with training they went to Ingham County for a week to train. Shifts are being adjusted to offer more coverage. 7:30AM-4:30PM and 12:00PM-9:00PM. Most calls seem to come around 5:00 when everyone is off work. M-F will not have an on-call office as ACO's will be on shift until 9PM. After 9:00PM a call should be made to central dispatch to have PD respond. This is a 90-day trial to see how it goes.
- 6. Staffing Working to get people who align with the vision of SCACC. Re-org will bring new positions and a change to public hours. New hours will be M-T-TH 7:30AM-4:30PM and Friday 8:00AM-5:00PM and Saturday 8:00AM-1:00PM. Wednesday Closed to the public. Working on sending employees to training.

place planned because some of the kennels are in rural areas, 30 minutes away and if an ACO gets there and the inspection cannot be completed it would have wasted valuable ACO time. Director Horton will speak to ACO's and get their feedback before making a decision.
