1. **William Stanuszek, SCMAC Director, re:**

- **1-21-1** Presented the Saginaw County Mosquito Abatement Commission 2024 Annual Report for review and discussion.

---Director Stanuszek spoke of new insights into the behavior and environmental influence of mosquitoes. The longer seasons, due to warmer temperatures, have an impact on the actions of Mosquito Control. For instance, the controlled flooding of the Shiawassee State Game Area, to produce waterfowl habitat, in combination with warmer temperatures, resulted in non-typical mosquito activity beyond the established season pattern. SCMAC is collaborating with the DNR to better understand the mosquito impact due to the changing seasons to be better prepared moving forward. Director Stanuszek gave updates on the new facility at 705 N. Towerline Rd. in Buena Vista Township stating they should be moved in by the last week of January 2025. SCMAC is the largest by size and budget in the area. SCMAC has 7 aircraft used in the spring, stored at HW Browne Airport (for a very minimal fee) and employ almost 60 seasonal employees; those who stay past the normal season are paid an extra dollar per hour. St. Charles area is most impacted by mosquitoes in Saginaw County due to the State game area, Shiawassee Wildlife Refuge, and river but for the past few years mosquitoes have been troublesome in Frankenmuth near the river. Director Stanuszek advised that the Monarch butterfly will likely be listed as endangered this year and they are working toward a solution. Extended-release products are being used to allow treatment of more than one area without increasing the labor resource. To ensure treatment is the most effective, it is not done if temperatures are below 55 degrees or too much wind. SCMAC is a community resource, not intended for private businesses, but they do offer education to them. There is a Saginaw Mosquito Notifications app that residents can load to their phones to stay informed about mosquito control activities, receive notifications of nighttime adult treatment planned for their area, and request mosquito control services.

1. Sandra Lindsey, CEO, Saginaw County Community Mental Health Authority, re:

- **3-18-1** Presented the Saginaw County Community Mental Health Authority 2024 Update pursuant to agreement
- ***Discussion was held. SCCMH provides for the publicly funded mental health needs of eligible people in Saginaw County. It is governed by a 12-member Board of Directors, appointed by the Saginaw County Board of Commissioners. It serves people with serious mental illness, emotional disorders, intellectual/developmental disabilities, and co-occurring substance use disorders. Staff go where the people who need them are, so there isn't much need for telemedicine. Lack of sufficient space available in the Medical Diamond is preventing SCCMHA from moving Behavioral Health and a pharmacy there. Due to the risk involved with patients not taking their medicine, and the importance of having the pharmacy, it was decided not to move to the Medical Diamond. When asked about employee safety, Ms. Lindsey reported there haven't been any major safety incidents caused by consumers. Domestic disputes caused by people who know the consumers happen occasionally. Ms. Lindsey spoke about SCCMHA's status of Certified Community Behavioral Health Clinic and contracts with Mid-State Health Network (MSHN) and Michigan Department of Health and Human Services (MDHHS) and being a certified Community Mental Health Services Program (SMHSP). The Mental Health Authority employs 280 full-time staff and 70 part-time staff and has done the required credentialing of 249 professional staff members. Ms. Lindsey discussed the Office of Recipient Rights (ORR) and their investigation of 239 allegations of rights violations in 2024. She also reported on SCCMHA continuing education and department trainings completed. She spoke of the 2024 program audits and external audits and accreditation. SCCMH has a 24/7 Mobile Response and Stabilization Service, and she discussed the many other services offered. Commissioners inquired about challenges anticipated in the near future. Underfunded public mental health systems, implementation of the Earned Sick Time Act and finding coverage for staff who are out sick was discussed and unfunded, mandated, demands of the State and uncertainty about Federal changes/cuts to several programs were disclosed as challenges. Ms. Lindsey finished by reporting on demographics and SCCMH financial statements.***

2. **Christina Harrington, Health Officer, Saginaw County Health Department, re:**

- **3-18-2** Presented a Summary of the BWell Saginaw Update/Year in Review
- **Health Officer Harrington reported that Saginaw County is ranked one of Michigan's least healthy counties and the present goal is to become one of the state's top 25 healthiest. The most urgent health priorities are obesity & chronic disease, maternal & child health and substance use. She advised the community is responding and reported that participation in "Strides Toward Wellness" nearly doubled in 2024. The next race is scheduled for September 26, 2025. "Start a Healthy Conversation with Your Doctor" campaign launches January 2025 and Step Up & BWell is Focusing on the health of students, staff and families in the county school districts. Saginaw County's Youth Commissioners have recommended "Chill Rooms" for schools to provide a space for students to decompress. Health Officer Harrington was happy to announce the RxKids program is coming to Saginaw. The program will offer no-strings-attached cash payments to expectant and new moms (up to child's 1st birthday). RxKids was created by Flint pediatrician Dr. Mona Hanna and the program has been very successful in Flint. State funding has been secured and to maintain the funding Saginaw needs to raise \$1.4 Million annually to help secure families in Saginaw County by helping to protect them from the income plunges and poverty spikes that happen right before a baby is born and through the child's first year. 1. **Sandra M. Lindsey, CEO, SCCMHA, re:**

- **8-19-1** Submitted a draft Resolution in Opposition to the Michigan Department of Health & Human Services (MDHHS) plans to competitively procure Michigan's Pre-Paid Inpatient Health Plan (*Resolution*)
- The Saginaw County Community Mental Health Authority Board passed a resolution on July 14, 2025, in opposition to the plan to initiate a competitive procurement process for the management of PIHP functions, if instated it may open the door to private, non-profit health plans or managed care organizations (MCOs) assuming control over behavioral health services. Commissioners discussed how allowing this could disrupt relationships between local mental health authorities, providers, and the communities they serve. These entities are not subject to the Open Meetings Act nor the Freedom of Information Act. Reduced quality of care, limited accessibility to preferred services, loss of local control, and lack of transparency were concerns addressed that are expected to affect citizens. Fees for services, which haven't happened since the 1990's, could have an impact on the services offered locally, and the quality of service. Since beneficial programs such as mental health training with law enforcement agencies, Sheriff's Department, and SVSU are not billable services, they may no longer exist if fee for service is implemented. Commissioner Webster suggested that if pre-paid Inpatient Health Plans are managed by a for-profit group, services will likely diminish and those managing the money will profit. Vice Chair Little advised that Michigan Association of Counties (MAC) has gone on record in opposition to the plan. Sandra Lindsey requested commissioners draft a resolution with the same language as her draft resolution and share it with MAC, Governor Whitmer, the Michigan Department of Health and Human Services (MDHHS) Director, Elizabeth Hertel, and Michigan Legislature.
- **Webster moved, seconded by Tany, to adopt the proposed resolution and forward to the full board for approval. Motion carried. (Res. 2025-12)**

2. **Jessica Sargent, Commission on Aging Director, re:**

- **8-19-2** Submitted its 2026 Application Summary for Federal/State Funding through Region VII Area Agency on Aging for discussion and approval (*Board Report*)

- Discussion was held about the Foster Grandparenting program having been cut. Chairman Tany asked if anyone has reached out to Saginaw County School District and Saginaw ISD to see if funding is available through the school. He acknowledged the Foster Grandparenting program as a win-win program that seniors, students, teachers and schools all benefit from. Director Sargent will inquire with them. She is hoping the grant funds will still come through, in which case, she will come back to committee to request to amend the budget. She shared that they can still have a presence in the school, but it might look different. They have the data, the network, dedicated volunteers, and a great track record in this program that will create opportunities. It takes just over \$1M in Federal dollars to run this program but they have volunteers who are willing to serve without charge. Commissioners recommended sharing testimonials and data to show how impactful the program is and suggested contacting the Community Foundation and business owners to offer them opportunities to sponsor them. Director Sargent will provide the amount of loss suffered from the lack of Federal support and the effect it has had. Commissioner Webster asked that the programs discontinued due to lack of funding be recorded so that, if money becomes available, the programs can be restored. He also requested a summary of changes between FY25 and FY26 in the budget resolution.
