To the Qualified Electors of the Cities of Saginaw and Zilwaukee and the Townships of Buena Vista, Carrollton, Kochville, Saginaw, Tittabawassee and Zilwaukee in the County of Saginaw, State of Michigan

**PLEASE TAKE NOTICE** that any qualified elector of the above-mentioned jurisdictions who is not already registered, may register to vote at the office of the Township or City Clerk; the Office of the appropriate County Clerk; a Secretary of State branch office, or other designated state agency. **Michigan residents with a valid Michigan driver's license or State ID can register online using the Michigan Online Voter Registration System at <https://mvic.sos.state.mi.us/>** Registration forms can also be obtained at <https://mvic.sos.state.mi.us/> and mailed to the Township or City Clerk. Voters who are already registered may update their registration at <https://mvic.sos.state.mi.us/>.

The last day to register in any manner other than in-person with the local clerk is Monday, January 19, 2026.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at their respective Township or City Clerk's office (listed below) at the following times:

- Saturday, January 31, 2026, from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, February 3, 2026, from 7:00 a.m. to 8:00 p.m.
