CHAIR ANNOUNCEMENTS

- Chairman Tany announced that the day after the November Board Meeting the Commission on Aging held its ribbon cutting at the Marie E. Davis Senior Center. Along with himself and Vice-Chair Little, commissioners Webster, Matthews and Piotrowski were in attendance as well as several employees. Administrator Hannah, Bill Stanuszek, Mary McLaughlin, and Kelly Suppes were there supporting Jessica Sargent and the Commission on Aging. Chairman Tany said that during Jessica's remarks, she gave a shout out to Maintenance Director, Tony DePelsMaeker and his crew, which was nice.
- Chairman Tany reported that the very next day, November 20th, was the dedication of the new warming house at Hoyt Park, which was a Memorial Cup Legacy Project of the Saginaw Spirit. He and Administrator Hannah were there along with Treasurer Novak and Parks Director, Brian Keenan-Lechel, who had a speaking part in the program.

- Chairman Tany announced that on Wednesday, December 3rd, he attended the Saginaw County Township Association's Holiday meeting in Frankenmuth. Commissioner Spitzer, Clerk Guerra, Deputy Clerk Bostwick and the Honorable Judge McGraw were also in attendance. He thanked them for representing Saginaw County.
- Chairman Tany thanked those who served as judges for the Commissioner's Cup, our Employee of the Year Award. He and Administrator Hannah, Commissioners Webster and Slodowski, the Honorable Judge Gafkay, Treasurer Novak, and Jaime Ceja chose the winners.
- Chairman Tany and Commissioner Webster were at the most recent STAR Court graduation on December 11th. He stated that he goes to support the graduates, The Honorable Judge Trice, and the program. He acknowledged Judge Trice for the time, effort and passion he puts into the STAR program and stated that attending is his way of thanking him.
- ❖ Chairman Tany announced he has been pushing for a display case to be installed in the atrium at the Dow Event Center to display the 3 different awards Saginaw County won for the Memorial Cup. The hockey jersey that the Saginaw Spirit gave, our updated logo, and a plate with the commissioner's names and the Administrator's name will be displayed. The Building Authority saw value in it and voted to approve it. Chairman Tany guaranteed that it will be our display case, not the Saginaw Spirit's display case.

COMMISSIONER AUDIENCES

- Commissioner Kaczynski announced that this is his first full year on the Board, and he has really enjoyed the experience. He congratulated Chairman Tany on a successful Christmas party last Friday and hopes we can do this for years to come.
- Commissioner Webster quoted Judge Trice, "Success is a journey, not the destination." Commissioner Webster spoke to the board about the eloquence with which Judge Trice spoke to graduates and recommended others go to the graduations to hear him.
- Commissioner Little thanked everyone for their involvement in the employee holiday party.
- Commissioner Coney announced that 30 backpacks were donated by the NAACP that will be filled with supplies and donated to students in need.
- Commissioner Spitzer attended the Saginaw Township Business Association on Thursday, December 11th. He appreciated that in lieu of admission cost, canned goods were collected to donate to the East Side Soup Kitchen. He acknowledged the McDonald Auto Group for raising \$5,000.

ADMINISTRATOR REMARKS

- Administrator Hannah recommended commissioners read the New York Times Athletic magazine article <u>Three days with the Saqinaw Spirit, where being different is the name of the game</u> written by Scott Wheeler.
- Administrator Hannah announced that the State House is pulling back Works funding. Funds have already been spent with the expectation that they would be reimbursed. She urged commissioners to reach out and get information from Michigan Association of Counties (MAC).
- Administrator Hannah shared the good news that Best Friends Animal Society, a national organization, is placing two fellows at Saginaw County Animal Care & Control and the cost will be paid for by Best Friends.
- Administrator Hannah informed the Board that discussions are on going about how to best use the space in the lower level of the courthouse. Only half of the space that was once used is still being used for storage.
- Administrator Hannah stated that audit work will begin shortly and she will update the Board next month.
- ❖ Administrator Hannah said the last CBA negotiations with Sheriff Deputies began this week.
- Administrator Hannah let the Board know that she is excited about the new Deputy Administrator Position and she has had great candidates apply. She disclosed the Benefits and Retirement Administrator position is being filled as well.

Administrator Hannah advised that once she has the cost allocation of the regional Medical Examiner's office, she will bring it to the Budget/Audit committee.
